Thank you for your inquiry.

To be assigned points under Skill transferability factors of the Comprehensive Ranking System per section 23 (Combination of foreign work experience and official language proficiency) or section 24 (Combination of Canadian work experience and foreign work experience) of the *Ministerial Instructions Respecting the Express Entry System*, a candidate's foreign work experience must meet the requirements specified in section 25 (Foreign work experience).

Unlike the requirements for Canadian work experience, there is nothing to preclude a period of employment during with the foreign national was engaged in full-time study from being included in calculating a period of foreign work experience for purposes of assigning points for Skill transferability factors.
